

## CONTRACT AGREEMENT

### “GARBAGE COLLECTION AND DISPOSAL AT BASEPORTS CY 2018”

THIS AGREEMENT entered into by and between:

**PHILIPPINE PORTS AUTHORITY (PPA)**, with local office at Barangay Loboc, La Paz, Iloilo City, Philippines, represented herein by its Acting Port Manager, **ENGR. EDUARDO P. GOLES** hereinafter referred to as Procuring Entity

- and -

**J. S Layson & Co., Inc.**, with business and office address at 113B St. Elizabeth Center, Valeria St., Iloilo City represented herein by its President, **JOSE V. LAYSON, JR** hereinafter referred to as the Supplier:

**WHEREAS**, the Procuring Entity invited Bids for the **“GARBAGE COLLECTION AND DISPOSAL AT BASEPORTS CY 2018”** and has accepted a Bid by the Supplier for the supply of those goods in the sum of **TWO MILLION SIXTY THOUSAND NINE HUNDRED SEVENTY-SIX PESOS ONLY (Php2,060,976.00)** hereinafter called “the Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1) In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2) The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a) Bid Form and the Price Schedule submitted by the Bidder;
  - b) the Schedule of Requirements;
  - c) the Technical Specifications;
  - d) the General Conditions of Contract;
  - e) the Special Conditions of Contract; and
  - f) the Procuring Entity’s Notification of Award.
- 3) In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4) The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS WHEREOF the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




