



**PHILIPPINE PORTS AUTHORITY (PPA)**, with local office at Brgy. Loboc, La Paz, Iloilo City, represented herein by its Acting Port Manager, **EDUARDO P. GOLES**, herein referred to as PPA

and

**F.GURREA CONSTRUCTION INC.**, with business and office address at **Q.ABETO STREET, MANDURRIO, ILOILO CITY** represented herein by its Proprietor, **ENGR.JANNETTE G. ANSINO**, hereinafter referred to as CONTRACTOR.

WHEREAS, PPA is desirous that the Contractor execute the **“Repair of Libertad Port, Libertad, Antique”** and the PPA has accepted the Bid for **Twenty Nine Million, Six Hundred Sixty-Nine Thousand, Forty-Six Pesos and 50/100 (P29,669,046.50)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.
