**KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION**, with business and office address at **KM. 10.5 PUROK 30, BARANGAY CABANTI-AN, BUHANGIN, DAVAO CITY** represented herein by its Proprietor, **ENGR. ARSENIO B. GROSPE**, hereinafter referred to as CONTRACTOR.

WHEREAS, PPA is desirous that the Contractor execute the “Repair of Port Roads, Pavement, and Slope Protection at Port of San Jose, Antique” and the PPA has accepted the Bid for **Fourteen Million Five Hundred Fifty-Eight Thousand Four Hundred Forty-Three Pesos and 87/100 (P14,558,443.87)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
