



**PHILIPPINE PORTS AUTHORITY (PPA)**, with local office at Brgy. Loboc, La Paz, Iloilo City, represented herein by its Port Manager, **EDUARDO P. GOLES**, herein referred to as PPA

and

**E.M PAULE CONSTRUCTION & TRADING INC**, with business and office address at **ILOILO SATELLITE OFFICE BRGY. PAGSANGA-AN, PAVIA, ILOILO** represented herein by its Proprietor, **ENGR.PIOLITO L. GALACAN**, hereinafter referred to as CONTRACTOR.

WHEREAS, PPA is desirous that the Contractor execute the “**Repair and Maintenance of Port Facilities at PMO-PNG, CY 2018**” and the PPA has accepted the Bid for **Four Million One Hundred Sixty-Five Thousand Two Hundred Forty-Two Pesos and 07/100 (P 4,165,242.07)**. by the Contractor for the execution and completion of such Works and the remedying of any defects therein.
