WHEREAS, the Entity invited Bids/Proposal and is desirous that the Contractor/Supplier execute "Repainting of PPA PMO Panay/Guimaras Admin Building" with project identification number Repair and Infrastructure Assets –A230005 (hereinafter called "the Works") and the Entity has accepted the proposal of Nine Hundred Ninety-Eight Thousand Four Hundred Eight-Three Pesos and 01/100 (Php 998,483.01) by the Contractor/Supplier for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
