PHILIPPINE PORTS AUTHORITY (PPA) of the Philippines (hereinafter called "the Entity") of the one part and RRL BUILDERS CORPORATION of 2nd Floor Joy Agro Bldg., Jalandoni St., Iloilo City, Philippines (hereinafter called "the Supplier") of the other part;

 - v. Supplemental or Bid Bulletins, if any
 - b. . Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract; and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **One Million Six Hundred Five Thousand Two Hundred Eighty-One Pesos and 68/100 (1,605,281.68)** or such other sums as may be ascertained, **RRL BUILDERS CORPORATION** agrees to execute and complete the Works and remedy any defects therein in accordance with his/her/its Bid.
