REPAIR AND REPAINTING OF VARIOUS MOVABLE CANOPIES (RM-NOS-03-16)

THIS AGREEMENT, made this _____ day of ______ between PHILIPPINE PORTS AUTHORITY, PMO-NEGROS ORIENTAL/SIQUIJOR of Port Area, Looc, Dumaguete City (hereinafter called the "Entity") and LMC CONSTRUCTION (hereinafter called the "Contractor").

 - 5. VAT Certificate of Registration
 - 6. Tax Clearance Certificate
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. The Contractor shall complete the works in accordance with the Drawings and the Bid Documents within **Thirty (30) Calendar Days**.
- 6. Should the Contractor refuse or fails to satisfactorily complete the works within the specified completion period inclusive of granted time extension, if any, the Contractor shall be liable for damages for the delay and shall pay the Entity Liquidated Damages (LD) in accordance with Annex "D" Section 3 of the Revised Implementing Rules and Regulations of R.A. 9184.
