Contract Agreement

REPAIR AND PREVENTIVE MAINTENANCE OF ADMINISTRATION BLDG., PPD OFFICE & QUARTERS AND GAD HOUSE (RM-NOS-04-16)

THIS AGREEMENT, made this ____ day of ____ between PHILIPPINE PORTS AUTHORITY, PMO-NEGROS ORIENTAL/SIQUIJOR of Port Area, Looc, Dumaguete City (hereinafter called the "Entity") and LMC CONSTRUCTION (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Repair and Preventive Maintenance of Administration Bldg., PPD Office & Quarters and GAD House (RM-NOS-04-16) (hereinafter called "the Works") and the Entity has accepted the Bid for Four Hundred Ninety-Three Thousand, Six Hundred Thirty-Two and 97/100 Pesos († 493,632.97) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Drawings/Plans;
 - (b) Bid Proposal (Quotation);
 - (c) Notice of Award of Contract and the Bidder's conforme thereto;
 - (d) Other contract documents that may be required by existing laws and/or the Entity.
 - 1. PCAB License
 - 2. DTI Business Name Registration or SEC Registration
 - 3. Current Mayor's Permit
 - 4. PhilGEPS Registration
 - 5. VAT Certificate of Registration
 - 6. Tax Clearance Certificate
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. The Contractor shall complete the works in accordance with the Drawings and the Bid Documents within **Sixty (60) Calendar Days**.
- 6. Should the Contractor refuse or fails to satisfactorily complete the works within the specified completion period inclusive of granted time extension, if any, the Contractor shall be liable for damages for the delay and shall pay the Entity Liquidated Damages (LD) in accordance with Annex "D" Section 3 of the Revised Implementing Rules and Regulations of R.A. 9184.
