

CONTRACT FOR THE

SUPPLY AND DELIVERY INCLUDING SETUP/INSTALLATION OF FURNITURES AND FIXTURES FOR THE PORT OPERATION BUILDING, PMO WESTERN LEYTE/BILIRAN

THIS AGREEMENT made and entered into this 11th day of May 2021 between:

PHILIPPINE PORTS AUTHORITY – PORT MANAGEMENT OFFICE OF WESTERN LEYTE/BILIRAN, a government instrumentality created under Presidential Decree No. 857, as amended, with office address at Lot 2, Block 13, Doña Feliza Mejia Subdivision, D. Veloso Street, Ormoc City, represented herein by the Port Manager **MR. BERNARD C. CALLEDO**, and hereinafter referred to as “**PPA**” of the one part;

PLANET PC PARTS AND SERVICES, a business duly organized and existing in accordance with Philippine laws with principal office address at Brgy. Mabolo, Catarman, Northern Samar represented herein by its duly authorized representative, **MICHELLE S. IBON**, of legal age, Filipino, per Special Power of Attorney dated March 27, 2021 and hereinafter referred to as “**SUPPLIER**” of the other part.

WHEREAS **PPA** invited Bids the **Supply and Delivery including Setup/Installation of Furniture and Fixtures for the Port Operation Building, PMO Western Leyte/Biliran** and has accepted a Bid by the Supplier for the supply of goods as contained and enumerated in the Terms of Reference in the sum of **Four Million Two Hundred Eighty Six Thousand Two Hundred Thirty Nine & 91/100 Pesos (P4,286,239.91)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier’s Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder’s response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity’s bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications and Terms of Reference;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity’s Notice of Award.
3. In consideration of the payments to be made by **PPA** to the Supplier as hereinafter mentioned, the Supplier hereby covenants with **PPA** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. **PPA** hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
