## ARTICLE I

### CONTRACT DOCUMENTS

1.01 The following documents shall constitute integral parts of this Contract, as fully as if the contents of the said documents are reproduced, incorporated and set forth herein, and shall govern and control in full force and effect the rights and obligations of the Parties, except as otherwise modified by the terms and conditions of this Contract, or by mutual agreement in writing of both parties, to wit:

- (2) Bidding Documents;
- (3) Winning bidder's bid, including the Technical and Financial Proposals and all other
- (4) documents/statements submitted;
- (5) Tax Clearance
- (6) Latest Income and Business Tax Returns
- (7) Certificate of PhilG-EPS Registration
- (8) Performance Security;
- (9) Credit line if awarded the contract for this project (CLC).
- (10) Organizational chart for the contract to be bid;
- (11) Notice of Award of Contract;
- (12) Construction Schedule and S-Curve;
- (13) Manpower Schedule;
- (14) Construction Methods;
- (15) Equipment Utilization Schedule;
- (16) Construction Safety and Health Program approved by DOLE;
- (17) PERT CPM;
- (18) Terms of Reference ( TOR)

1.02 The following documents shall also be made integral parts of this Contract as if their contents are incorporated, reproduced and set forth herein, and shall have the same force, effect and applicability as the documents enumerated in the immediately preceding paragraph hereof, to wit:

- (19) Duly Approved Program of Work and Cost Estimates
- (20) Certificate of Availability of Funds
- (21) Approved Budget for the Contract
- (22) Abstract of Bids
- (23) Resolution of the BAC Recommending Award
- (24) Concurrence of Lending Institutions in case of Foreign-Assisted Projects
- (25) Other pertinent documents as may be reasonably required by existing laws.

1.03 All Contract documents are and shall remain as the property of the PPA.


1.04 The words and expressions in the Contract shall have the same meanings respectively assigned to them in the Contract Documents referred to above.


