Award of Contract for the PROPOSED DREDGING OF SOUTH HARBOR FAIRWAY CHANNEL LEADING TO PIERS 3 TO 13, SOUTH HARBOR, MANILA LEP PMO NCS NO. 031-2015

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation To Bid for the Proposed Dredging of South Harbor Fairway Channel Leading to Piers 3 to 13, South Harbor, Manila, in the Manila Bulletin, a newspaper of general nationwide circulation on 09 October 2015 and posted the same in the website of the PPA, PhilGEPS and at a conspicuous place in the PPA premises, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is ₽ 213,235,681.98;

WHEREAS, in response to the said advertisement, four (4) prospective bidders secured and submitted the corresponding Bid Documents in the amount of ₽ 50,000.00, namely:

- 1. Equi-Parco Construction Company
- 2. IBC International Builders Corporation
- 3. Luck-well Construction
- 4. WTG Construction and Development Corporation

WHEREAS, during the opening of bids on 24 November 2015 at 10:30 a.m., the four (4) bidders were declared "passing" with the requirements of the First Envelope as shown in the attached Checklist of Bidding Documents (Annex "A");

WHEREAS, the Financial Proposals of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairman, as follows: (Copy of the Abstract of Bids as Read attached as Annex "B");

WHEREAS, Bid Evaluation was conducted on 25 November 2015 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report (Copy attached as Annex "C"), as approved by the BAC on 26 November 2015, showed discrepancies between the Total Bid Prices and Unit Bid Prices of IBC Int'l Builders Corp., WTG Const., and Dev't. Corp., Equi-Parco Const. Co. and Luck-well Const., as follows:

WHEREAS, post-qualification was conducted to examine, validate and verify the eligibility, technical and financial requirements submitted by IBC Int'l Builders Corp. and in the Post-Qualification Report (Copy attached as Annex "E") approved by the BAC on 09 December 2015, IBC Int'l Builders Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **IBC INTERNATIONAL BUILDERS CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of South Harbor Fairway Channel Leading to Piers 3 to 13, South Harbor, Manila, in the amount of **TWO HUNDRED SEVEN MILLION TWO HUNDRED SIXTY TWO THOUSAND SIX HUNDRED TWENTY PESOS (\$\mathbb{P}\$ 207,262,620.00), inclusive of taxes, to the said bidder.**
