Performance Security which shall be equivalent to Ten percent (10.0%) of the Contract Price in Cash or Cashier's/Manager's Check issued by a Universal Bank or Commercial Bank; Ten percent (10.0%) of the Contract Price in the form of Bank Draft/Guarantee or Irrevocable Letter of Credit issued by a Universal or Commercial Bank; or Thirty percent (30.0%) of the Contract Price in Surety Bond callable upon demand issued by a surety or insurance companies duly certified by the Insurance Commission as authorized to issue such security or any combination of the foregoing. In the execution of the performance bond, the following conditions shall be complied with:

1. The Performance Bond shall be co-terminus with the issuance of the final Certificate of Acceptance of the project;
2. It shall be callable on demand;
