SCOPE AND DETAILS OF WORK:

A. Area for Treatment

Head Office	52m x 37.50m	179 linear meters
GAD Center	60.70m x 60m	241.40 linear meters
PPATI building	57m x 50m	218 linear meters

B. For Crawling and Flying insects (cockroaches, ants, mosquitoes, flies, etc.) control:

1. Prior to the general pest control treatment work detail, Storm Fumigation and General Pest Control Service Technicians will do a thorough inspection of the office so as to determine where there are signs of heavy infestation of flying and crawling insects.
2. A high-performance residual insecticide will be administered by means of fogging, misting and surface spray.
3. Storm Fumigation and General Pest Control Service Technicians will also use cockroach gel baits, sticky traps when the need arises.

C. For Rats and Mice control:

1. For rodent control, Storm Fumigation and General Pest Control Service Technicians will do a thorough inspection of the premises to determine where there are high rodent activities.
2. Once rodent activity is pin-pointed, Storm Fumigation and General Pest Control Service Technicians will administer the chemical and install mechanical cage traps or glue traps every 10 linear meters along walls and or rodent bait stations, behind furniture and appliances, and in dark places where there are signs of rodent activity. To be done only when Storm Fumigation and General Pest Control Service Technicians have considered the area to be highly infested.

D. Other Terms and Conditions:

1. Frequency: One a month, schedule to be set with the Administrative Service Department.
2. All personnel of the Service Provider shall have valid company IDs.
3. Services shall cover a period of six (6) months, from August 2018 to January 2019.
4. The Service Provider shall bill the PPA on a monthly basis. Payment will be processed with seven (7) days from receipt of billing by the PPA.
