The PMO-NCR North BAC shall not compensate or indemnify any person for any expenses incurred in the preparation of the price quotation.

Moreover, the PMO-NCR North BAC reserves the right to accept or reject any price quotation, waive any formality in the RFQ, annul the procurement process, reject any or all price quotations at any time prior to contract award, declare the procurement process a failure, without thereby incurring any liability to the affected Participating Contractor/Service Provider or any person.
