

REQUEST FOR QUOTATION

1. The Philippine Ports Authority, Port Management Office of NCR North (PPA PMO-NCR North) through PMO NCR North Bids and Award Committee (PMO-NCR-NORTH-BAC), will undertake procurement of "Comprehensive Pest Control Works at PMO NCR North Admin.Bldg., Port Police Bldg., Annex Bldg. including Storage Areas at Container Vans, Engg. Barracks, Bahay Silungan, Terminal Office at Pier 18,VTSD Control Center" in accordance with Section 53.9 (Small Value Procurement) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184. The details of the project are the following:

f. Scope of Works :

1. Supply Labor, Tools, Materials and Equipments

a. Supply labor, tools, materials, equipments and technical pest management procedures that best addresses the pest condition on the area requirement.

2. Space Spray Treatment (Misting)

a. Application of water based ultra-low volume sprays or oil based clouds of smoke containing minute particles of insecticide for the control of flying insects and those that have escaped coarse sprays.

b. Accomplished by delivery of ULV (Ultra Low Volume) amounts of insecticide using a fogging or misting machine for the effective control of flying insects like mosquitoes, flies, and cockroaches.

3. Surface Spray

- a. Application of either residual or contact insecticide sprays directly on foraging insects, where they converge, their harborage, passageways and entry points.
- b. Primary method for the control of crawling insects.
- c. Accomplished by delivery of coarse sprays of insecticides solution using a compressed air sprayer.
- d. For the effective control of all crawling insects and insects habitat like garbage bins, etc.
- g. Delivery Period : Three (3) Months
- 2. The duly accomplished Price Quotation Form (Annex "A") and the certified true copy of the following documents must be placed in a sealed envelope and submitted in accordance with Item No. 3 hereof:
 - a. Mayor's/Business Permit
 - b. PhilGEPS Registration Number
 - c. Income/Business Tax Return
 - d. Omnibus Sworn Statement

Non-submission of any of the above required documents shall be a ground for disqualification.

Original copies of documents should be presented during the conduct of the scheduled Post Qualification. Failure to comply with the presentation of the original copies of required documents shall mean disqualification and the BAC shall conduct the Post Qualification of the next bidder with the Lowest Calculated Bid.

- 5. Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by the Supplier or his/her duly authorized representative.
- 6. Prospective bidder shall be a duly licensed Filipino citizen/sole proprietorship, partnership, corporation, cooperative duly organized under the laws of the Philippines or a joint venture with at least sixty percent (60%) interest or outstanding capital stock belongs to Filipino business partner.
- 7. PMO-NCR North reserves the right to reject any or all quotations at any time prior to award of the project without thereby incurring any liability to the affected proponents and

- to waive any minor defects therein, and to accept quotation as may be considered advantageous to the government.
