



REQUEST FOR EXPRESSION OF INTEREST

FOR

**PROCUREMENT OF HYDROGRAPHIC AND TOPOGRAPHIC SURVEY
AT THE PROPOSED PORT OF BACONG, BACONG NEGROS ORIENTAL
(CON-NOS-02-18)**

1. The *Philippine Ports Authority, Port Management Office of Negros Oriental-Siquijor (PPA, PMO-NO/S)*, through the Corporate Budget of the Authority for CY 2018 intends to apply the sum of **₱ 199,133.20** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Hydrographic and Topographic Survey at the Proposed Port of Bacong, Bacong Negros Oriental (CON-NOS-02-18)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PPA, PMO-NOS now calls for the submission of eligibility documents for the Procurement of Hydrographic and Topographic Survey Works. Interested consultants must submit their Eligibility Documents on or before July 24, 2018 at 9:30 AM at PPA, PMO-Negros Oriental/Siquijor. Applications for Eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. The BAC shall draw up the short list of consultants from those who have submitted eligibility documents and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its 2016 Revised Implementing Rules and Regulations (IRR). The criteria and rating system for short listing are:

4. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised IRR of RA 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. The Procuring Entity shall evaluate bids using the Quality-Cost Based Evaluation (QCBE) procedure, the Technical Proposal and Financial Proposal of the eligible bidder shall be given a weight of 70% and 30% respectively. The criteria and rating system for the evaluation of bids shall be provided in the Instruction to Bidders.
6. The Eligibility Documents (Part I) may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee of **Five Hundred Pesos (Php 500.00) inclusive of VAT**. Bidding documents (Part II) shall be made available only to shortlisted Consulting Firms/Consultants.
7. The contract shall be completed within **Twenty (20)** calendar days.


