The Philippine Ports Authority, Port Management Office of Lanao del Norte/ Iligan, through its Bids and Awards Committee (BAC), invites registered Contractors/ Consultancy Service Providers/ Research and Experimental Developers to bid for the hereunder contract:

- A. Name of Contract : ECC and SEP Application for Sultan Naga Dimaporo Port
- B. Location : Port of Sultan Naga Dimaporo, Lanao del Norte
- C. Brief Description :
The project involves Application and Processing of Environmental Compliance Certificate (ECC) and Strategic Environmental Plan (SEP) Certificate for Sultan Naga Dimaporo Port, Supply of travel, materials (office supplies), labor, meetings, fees, and miscellaneous expenses necessary to complete the filling and securing of an Environmental Compliance Certificate (ECC) and Strategic Environmental Plan (SEP) Certificate for Sultan Naga Dimaporo Port and submission to EMB Region 10 of the Environmental Performance Report and Management Plan (EPRMP).
- D. Approved Budget for the Contract (ABC): Php 759,834.60
- E. Source of Fund : PPA Corporate Fund
- F. Contract Duration : 150 calendar days

Prospective bidders shall submit Sealed Bid Proposals together with the following documents;

1. Certified True Copy of Valid and Current Mayor's Permit
2. Certified True Copy of Valid DTI Business Name Registration/ SEC Registration or BIR Certificate of Registration
3. For individuals engaging in the required works, only the BIR Certificate of Registration shall be submitted in lieu of DTI Registration and Mayor's Permit
4. Professional License/ Curriculum Vitae
5. Certified True Copy of Phil-GEPS Registration
6. Certified True Copy of Latest Income/ Business Tax Return
7. Omnibus Sworn Statement

Only those contractors with the certified copy of license/registration will be issued Bidding Documents. For purposes of verification, please present original copy of license/registration. A complete set of Bidding Documents may be acquired by interested Bidders from the address below upon payment of a non-refundable fee of **One Thousand Pesos (P1,000.00)**.

Prospective bidders should possess key personnel and must have completed a contract similar to the contract to be bid and with the same major categories of work as the contract to be bid with a value of at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO price indices, and

must meet the other eligibility, technical/project, and financial requirements and other requirements stated in the Eligibility Statement Form and the Bidding Documents.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships or organizations with at least 60% interest or outstanding capital stock belonging to citizens of the Philippines.


