A complete set of Bidding Documents may be acquired by interested Bidders from the address below upon payment of a non-refundable fee of **One Thousand Pesos (P1,000.00)**.

Prospective bidders should possess key personnel and must have completed a contract similar to the contract to be bid and with the same major categories of work as the contract to be bid with a value of at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO price indices, and must meet the other eligibility, technical/project, and financial requirements and other requirements stated in the Eligibility Statement Form and the Bidding Documents.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships or organizations with at least 60% interest or outstanding capital stock belonging to citizens of the Philippines.

The Philippine Ports Authority, Port Management Office of Lanao del Norte/ Iligan reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
