The Philippine Port Authority, PMO-Zamboanga del Norte, through its Bids and Awards Committee will undertake Negotiated Procurement – Sec.53.9. Interested bidders are required to submit their **valid and current Mayor's Permit, Phil-GEPS Registration Number, PCAB License (Small B-Building and Industrial Plant), Income/Business Tax Return, DTI/SEC Registration, Tax Clearance, and Omnibus Sworn Statement** unless the same were already submitted prior to this procurement. For methods of procurement requiring Mayor's Permits & Phil-GEPS Registration, Certificate of Platinum Memberships may be submitted in lieu of the said documents. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

Only sealed Quotation from eligible bidders will be opened and a contract will only be awarded to the Lowest Calculated Responsive Bidder who was determined as such during post-qualification. Quotation submitted thru e-mail shall not be accepted. Further, if quotation is submitted personally, bidder must submit a SPA or Secretary's Certificate, whichever is applicable, otherwise the same will not be accepted.

The winning bidder shall be required to post a performance security prior to the signing of contract in accordance with Sec. 39 of the 2016 IRR of RA 9184. The same shall be posted and shall be released after the issuance of the Certificate of Final Acceptance.

Opening of quotation shall be on **May 15, 2023, 2PM** at the PPA Conference Room, PMO-Zamboanga del Norte, Port Area, Dapitan City.

The PPA, PMO-Zamboanga del Norte reserve the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
