### **SUPPLY AND DELIVERY OF PANTUM INK TONERS (PC-210)**

Relative to the Bidding Documents for the Supply and Delivery of Pantum Ink Toners (PC-210) (BAC-PGCS -135-2020), which was posted in the PhilGEPS and PPA websites on 26 November 2020, please be informed of the following amendments thereto, as follows:

#### **I. ON THE INVITATION TO BID (IB)**

- a. The Title should be changed to SUPPLY AND DELIVERY OF ORIGINAL BRANDED INK TONERS.
- b. All references to Supply and Delivery of Pantum Ink Toners (PC-210) should be changed to Supply and Delivery of Original Branded Ink Toners.

#### **II. ON THE INSTRUCTIONS TO BIDDERS (ITB)**

##### **a. Scope of Bid**

The Procuring Entity, PHILIPPINE PORTS AUTHORITY wishes to receive Bids for the Supply and Delivery of Original Branded Ink Toners, with identification number BAC-PGCS-135-2020.

##### **b. Funding Information**

The PHILIPPINE PORTS AUTHORITY through its corporate budget for the Calendar Year (CY) 2020 in the amount of TWO MILLION FOUR HUNDRED THOUSAND PESOS (Php2,400,000.00).

2. Winning Bidder must be able to provide a Certification that all products to be delivered to PPA are Original.
3. All bids shall be considered fixed prices and not subject to price escalation during contract implementation.
4. Must have completed a single contract similar to the contract to be bid whose value must be at least equivalent to fifty percent (50%) of the ABC. For this purpose, a similar contract means contract for the Supply and Delivery of Original Branded Black Laser Ink Toner Cartridges.
5. The bidder should submit a Certificate of Compatibility issued by the Manufacturer, if the ink being offered is not the same brand with that of the previously issued Pantum Printer P2500W.

a. All references in the Objectives, Scope of Work, Technical Specifications, Delivery and Payment to Pantum Ink Toners (PC-210) should be changed to Original Branded Ink Toners.

2. Winning Bidder must be able to provide a Certification that all products to be delivered to PPA are Original.
