20/1 counts, 220gsm to 230gsm +/- 5%

Sizes: Actual Measurement

4. GENERAL REQUIREMENTS

- Bidder must provide actual sample of the cloth/material and logos, both for Polo Shirt and Short Sleeve Polo, to be used as prescribed in the technical specifications during submission and opening of bids. Certification from the manufacturer that the cloth/material for the Polo Shirt is Chief Value Cotton (CVC), Lacoste Pique, 60% Cotton and 40% Polyester, 20/1 counts, 220gsm to 230gsm +/- 5%, must also be submitted as part of the technical proposal.
- For the Short Sleeve Polo, initial taking of the body measurement and fitting shall strictly be undertaken within the PPA premises. In no instance shall an employee be obliged to go to the shop of the Supplier for re-

measurement, fitting and re-fitting. The Supplier shall strictly comply with the actual measurement of each individual instead of using category sizes such as small, medium and large.

- The Supplier shall make the necessary alterations pertaining to sizing, width and length of the Short Sleeve Polo or completely replace the same, as the situation may warrant, free of charge. The duly altered Short Sleeve Polo shall be delivered within two (2) weeks from receipt of the Short Sleeve Polo subject to alteration or replacement.


